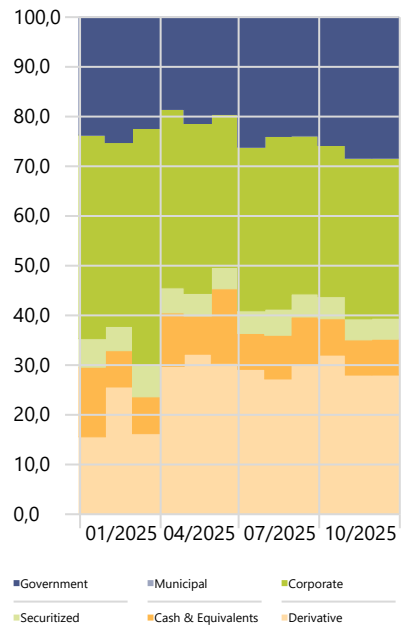


Fixed Income Country - Top 10
