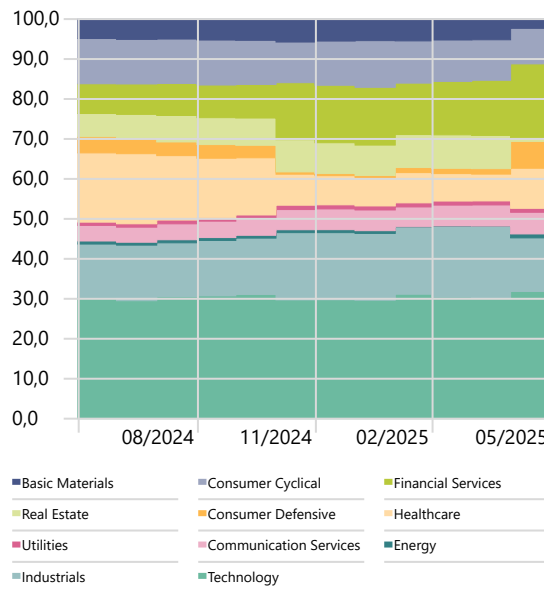

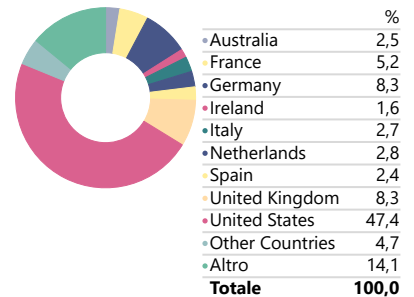
Equity Country - Top 10

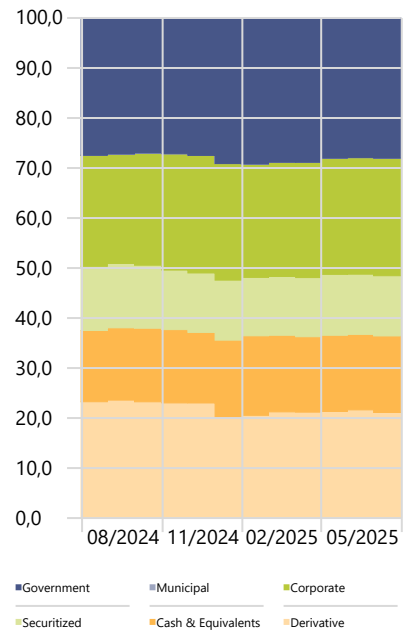
Fixed Income Country - Top 10

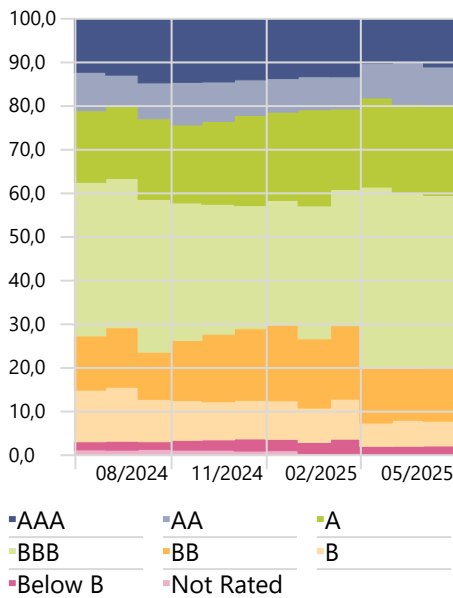

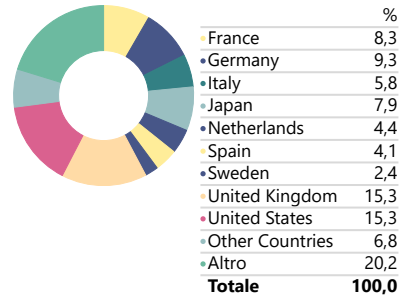
Equity Country - Top 10

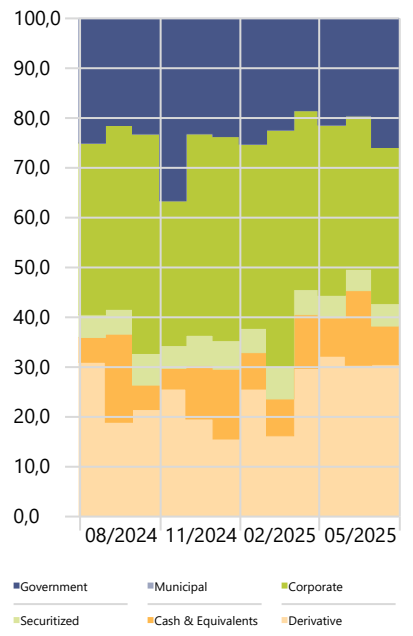
Fixed Income Country - Top 10

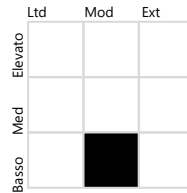

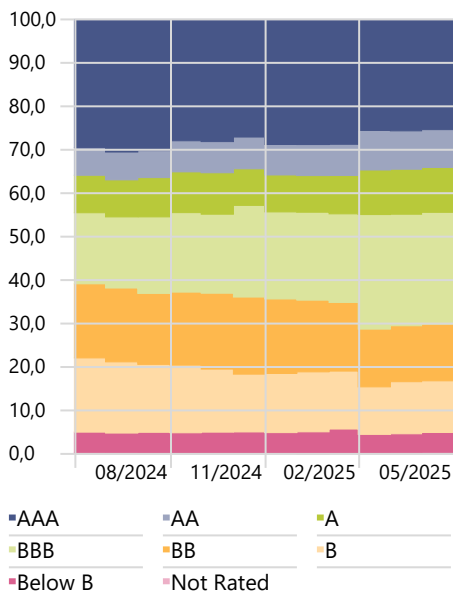

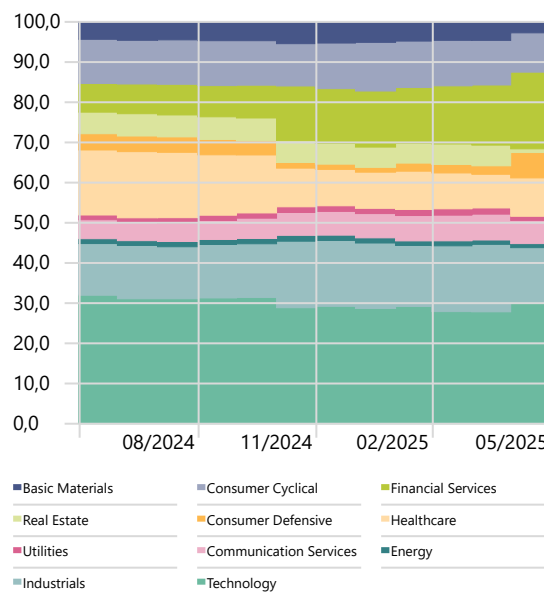

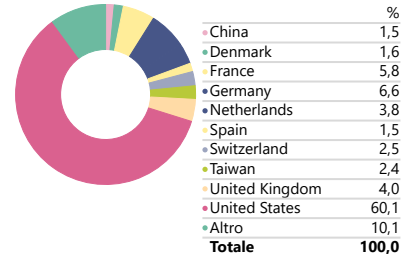
Settori Equity

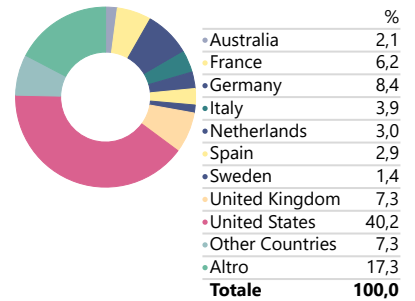
Equity Country - Top 10
